Our main 2 services are:

##### **1) Helping the Asylum Seekers**

We give donations of living subsidizes (money) to this group who is rejected by society. The government subsidizes HK\$1,500 per month for living expenses only, this subsidy is below subsistence level. NWMHK is benefiting the society to help these people in money, food, supplies and clothing donated by us and other NGOs. They can feel warm because of we are willing to help and care for them. We also benefit the society to helping them to improve emotionally living in Hong Kong and hopefully to become more better person in the society.

##### **2) Deep-Level Healing Programs every quarterly**

We are able to discover past hurt areas which they are not aware such as childhood or during adolescence. By recognizing these hurts, they are able to deal with by releasing through forgiveness of others and ourselves. Hopefully, according to the healing program can helping them to feel console and build up more confident in the life.


